Dear Ms. Mitchell:

The Southern Nevada Water Authority (Authority) has recently reviewed the Amended Agreement for Interstate Banking dated January 1, 2005 (Agreement). The conditions envisioned at the time the Agreement was executed have changed. For example, at the time the Agreement was executed the parties anticipated that the Authority would begin recovering Long-term Storage Credits as early as 2007. Current projections indicate that no water banked pursuant to the Agreement will be recovered for several years. There also appear to be other areas where the parties could add flexibility to the agreement in light of these changed circumstances.

The Authority is currently discussing recovery opportunities with the Central Arizona Water Conservation District (CAWCD) and the Arizona Water Banking Authority (AWBA). During these discussions the subject of credit recovery as a means of creating Intentionally Created Unused Apportionment has been raised. This method of recovery is recognized in the Storage and Interstate Release Agreement, and is included in the Metropolitan Water Authority's agreement with the CAWCD and the AWBA. The Authority's Agreement does not currently include this type of provision and we would like to discuss the inclusion of this method of recovery in the Agreement.

The Authority has reviewed the AWBA's recently approved 2009 Plan of Operation (2009 Plan) and notes that it does not currently include any water scheduled for interstate water banking. As you are aware, the Agreement calls for a \$23 million payment for the purchase and storage of water in 2009 into an Operation Account. While the Authority stands ready to make this payment, discussing options for more flexibility in making future payments seems prudent given current fiscal conditions.

We look forward to scheduling an opportunity with you to discuss creating additional flexibility in the operation of the Agreement at your earliest convenience.

The Arizona Water Banking Authority (AWBA) has reviewed the letter from Ms. Kay Brothers, dated January 5, 2009 requesting the Amended Agreement for Interstate Water Banking (Agreement) be adjusted to better reflect current conditions. The AWBA agrees that some minor modifications to the Agreement are in order. The AWBA would suggest that in addition to the areas pointed out in the January 5 letter, the sections on the timing of the initial request for intentionally created unused apportionment (ICUA) and the procedure for requesting ICUA could also be modified.

In order to facilitate these modifications to the Agreement, the AWBA is willing to toll any performance dates provided in the Agreement for a period of 60 business days effective immediately. If this is acceptable to you, please countersign and date this letter as a temporary addendum to the Agreement. Two additional originals of this letter are also enclosed for signature. Upon execution of these letters, please retain one fully executed letter for each of your files and return one fully executed letter to the AWBA.

We will make staff available to work with you and your staff to make permanent modifications to the Agreement. In order to facilitate that process we have provided some suggestions on how the Agreement could be modified to accomplish both our purposes.

Changes to the Amended Agreement for Interstate Water Banking

Add two definitions

"Recovery" shall mean the recovery and exchange of Long-term Storage Credits for Colorado River water in that year and or credit exchange of Long-term Storage Credits for Colorado River water that would have otherwise been delivered for underground storage in that year.

"Recovery Facilities" shall mean constructed facilities capable of recovering both intrastate and interstate Long-Term Storage Credits.

Add

2.4.1.4 The schedule dates and periods established by this Subarticle 2.4.1 may be changed upon written agreement of all parties.

Modify 3.1

- 3.1.1 SNWA shall have the right to require the recovery of Long-term Storage Credits in the SNWA Interstate Account and the development of ICUA in any Year, as follows:
 - 3.1.1.1 The initial year request for ICUA shall not exceed 20,000 acre-feet, the second year request for ICUA shall not exceed 30,000 acre-feet and any request for ICUA thereafter shall not exceed 40,000 acre-feet.
 - 3.1.1.2 The amount of annual ICUA established by this Subarticle 3.1.1 may be changed upon written agreement of all parties.

Modify 3.2.1

3.2.1 For any Year in which SNWA will require the development of ICUA by AWBA and the release of ICUA by the Secretary, SNWA shall confer with the AWBA prior to June 1 of the preceding Year and provide notice of the amount of such ICUA to AWBA by June 1 of the preceding Year.
